- Pastor Asquith to receive a salary increase of \$50.00 per week to begin the month following the July business meeting. Pastor Asquith will also receive a check for \$1500.00 as a one-time salary payment. This pay increase will be monitored prior to the January business meeting to determine the fiscal health of the church and the church will vote to either continue or stop it.
- Pastor Hain to receive \$150.00 per week for the next 12 months. The entire amount of \$7800.00 will be drawn from available funds and will be set aside for disbursement. The amount of \$3900.00 representing his salary from July through December shall be immediately given to him in one check. The balance of \$3900.00

representing his salary for the first half of the year will be sequestered in the church account until the first Sunday of January 2022 when it will be given to him in full. The church will use the January business meeting to determine the effect of those two payments upon the capabilities of the church to keep abreast of its obligations. If it is determined that the church has functioned efficiently with such payment having been made, then they will vote to repeat the procedure again in July and the following January. If by July of 2022 the church realizes that payments of \$150.00 per week to Pastor Hain are no detriment to this church's ability to keep current with its responsibilities, then the church will vote to see to it that he is paid on a monthly basis instead of twice yearly.
